TERMS & CONDITIONS

1. No food, wines or spirits may be brought into the venue by the client or its guest. 2. Prices quoted are inclusive of vat (unless otherwise stated) at the rate which prevails when this contract was prepared and are subject to alteration should the vat rate change. The price quoted are in respect only of the booking of seats/tables at the function and any meal or beverages which may be specified by NRL. 3. All bookings must be accompanied by a deposit of £10 per person of revenue in cleared funds, such sum not to be refundable in the event of cancellation of a booking by the client in accordance with condition 4 below in addition to any other cancellation fee payable should the booking be cancelled not more than 60 days before the date of the function. 4. All cancellations by the client must be advised, in the first instance, verbally, followed within a period of 24 hours, by confirmation by email (events@newcastle-falcons.co.uk) or registered post. 5. For the purpose of the terms and conditions "revenue" shall mean the price payable by the client for the booking being the total price as stated on the booking form. 6. NRL will incur no liability for any failure to provide or carry out any function if prevented from doing so by any cause beyond its responsible control. In this circumstance, NRL will endeavour to arrange alternatives times and dates for the function to take place. If NRL fails to re-arrange the function to the reasonable satisfaction of the client, then any monies paid by the client shall be refunded but this shall be the limit of NRL's liability. 7. NRL can accept no responsibility for the property of the client or its guests at the venue. Cloakroom and car parking facilities are provided only for the convenience of the clients and its guests. All goods or vehicles are deposited at the owners risk and without obligation on the part of NRL, except when the loss or damage to the goods or vehicles has occurred as a result of negligence of NRL or its employees. 8. The client will indemnify and keep indemnified NRL against any costs, losses, claims, actions, damages or expenses suffered or incurred by NRL resulting (whether directly or indirectly) from any actions of or by the client or the guests of the client. 9. The clients shall be responsible for any damage caused to the stadium or its furnishings and equipment therein by the wilful act or default of the clients and its guests. The client shall pay NRL on demand the amount required to make good or the remedy any such damage. 10. The client shall at all times comply with and ensure that its guests comply with all conditions and regulations made in respect of the stadium by the local authority, The fire authority, the local magistrates court and any other regulatory body whatsoever. 11. The clients shall not bring into or place in the stadium or its environs any flammable, combustible, dangerous or objectionable items, substances or liquids. 12. NRL reserves the right to refuse admission to or remove from the stadium any person who acts in a disorderly manner or any person (or item) which otherwise breaches the provisions of these conditions. 13. Dress code will be advised by NRL prior to the function and must be adhered to. NRL reserves the right to refuse admission to or remove from the stadium any person who fails to adhere to the specified dress code. 13. In the interest of the public concern we may ask to search your bag upon arrival.
